JUDGMENT IN A CIVIL CASE**

[X] Decision by Court. This action came before the Honorable Joseph F. Anderson, Jr., presiding, and the issues having been duly heard and a decision having been rendered, the court grants plaintiffs' motion for judgment as a matter of law.

IT IS ORDERED AND ADJUDGED that the Section 12(a)(2) claims against all defendants are dismissed with prejudice.

IT IS FURTHER ORDERED AND ADJUDGED that the Section 11 claims against all defendants are dismissed with prejudice to the extent they arise out of purchases of bonds that occurred prior to the effective date of the registration statement for such bonds ("Pre-registration Section 11 Claims").

IT IS FURTHER ORDERED AND ADJUDGED that judgment as a matter of law is hereby entered in favor of the class and plaintiffs State Street Research Income Trust and American High Income Trust against defendants Kenneth W. Winger and Paul R. Humphreys as to all claims except the Section 12(a)(2) claims and the Pre-registration Section 11 Claims referenced above.

IT IS FURTHER ORDERED AND ADJUDGED that the class under Section 11 and Section 15 claims based on bonds purchased after the effective date of the registration statement shall recover from defendants Kenneth W. Winger and Paul R. Humphreys, jointly and severally, in the amount of One Hundred Sixty Three Million, Five Hundred Twelve Thousand, Four Hundred

Twenty and no/100 Dollars (\$163,512,420.00) (\$134,151,792.00 for the purchasers of the 2008 Bonds and \$29,360,628.00 for the purchasers of the 2009 Bonds).

IT IS FURTHER ORDERED AND ADJUDGED that the plaintiff American High Income Trust under Section 10(b), Section 18 and Section 20(a) claims shall recover from defendants Kenneth W. Winger and Paul R. Humphreys, jointly and severally, in the amount of Twenty One Million, Seven Hundred Sixty Four Thousand, One Hundred Fifty One and no/100 Dollars (\$21,764,151.00).

IT IS FURTHER ORDERED AND ADJUDGED that the plaintiff State Street Research Income Trust under Section 10(b), Section 18 and Section 20(a) claims shall recover from defendants Kenneth W. Winger and Paul R. Humphreys, jointly and severally, in the amount of Seven Million, Four Hundred Fifty Thousand, Two Hundred Seven and no/100 Dollars (\$7,450,207.00).

IT IS FURTHER ORDERED AND ADJUDGED that summary judgment is hereby entered in favor of defendant TD Securities (USA), Inc. against lead plaintiffs American High Income Trust and State Street Research Income Trust as to the claim under Section 10(b).


IT IS FURTHER ORDERED AND ADJUDGED that defendant Laidlaw, Inc. is hereby dismissed with prejudice as to all claims.
